Dear Stakeholder

I am writing to consult with you over the proposed change of age range at Coritani Academy (part of Isle Education Trust) from an 11-18 to a 7-18 provider alongside a proposed change of site from the current Henderson Avenue location to premises at Wyredale Road, Scunthorpe. This is as a result of an approach made by the Local Authority to extend the offer of high-quality alternative provision already in place at Coritani to younger, Key Stage 2 children for North Lincolnshire and the surrounding area.

The proposal would see Coritani Academy relocating to the Wyredale Road site which would provide additional facilities not available at the current Henderson Road site as well as offering approximately 20 additional places for identified younger pupils (7 to 11 years old). This would take Coritani's student numbers to approximately 40 in total. The extended provision would continue to work with young people for whom a mainstream setting is not working, in order that they may have access to a wide and varied curriculum alongside additional bespoke support and services in order that they can either return to their home school or remain at the academy to take examinations. The aims, ethos and values of Coritani remain unchanged; to equip all learners with the skills necessary to go on to their chosen next steps. The consultation on this proposal will be for 8 weeks from 24 April 2020 to 24 June 2020.

Normally a meeting would be held during this period with all interested parties to answer questions, however, in the current circumstances, a date for this has not yet been set. If it becomes safe to do so we will advertise the date and venue of a meeting, however there is a possibility that such a meeting will not be able to take place. Therefore, if you have any specific questions, please use the response form to raise these. Similarly, if you would like someone to contact you to discuss this proposal, please indicate this on the response form.
